## Speaker—Filomena Trujillo-Mealy IRS Senior Stakeholder Liaison

As an eighteen year veteran, Filomena has held several positions ranging from Auditor, Quality Reviewer, Electronic Filing Coordinator and Earned Income Tax Credit (EITC) Coordinator. She spent close to a decade assigned to the Taxpayer Education Office, where she actively promoted and increased public awareness of the EITC eligibility requirements.

Currently, Filomena is a Senior Stakeholder Liaison in the Pennsylvania, New Jersey Territory Stakeholder Liaison Office of Internal Revenue Service's Small Business/ Self-Employed Division. Her responsibilities include working with the Practitioner Community to increase electronic filing as the Philadelphia Project Lead for e-Submissions. She is also the Philadelphia Territory Lead for Childcare Provider Industry and has been credited for her active involvement in drafting educational guides and identifying a major stakeholder that initiated the "Standard Meal Rate" for Daycare Providers as the first Burden Reduction initiative.

During her tenure with the IRS she has conducted numerous presentations to the small business, general and practitioner community covering topics ranging from electronic filing, e-services, information returns, employment taxes and tax law changes etc.
